Dear Parents,

Autumn seems to be upon us with the wet and windy weather we have had this week. A reminder to please send the children to school with a warm waterproof/resistant coat every day.

As you know our community school is very much part of the wider community group. Yesterday I met with an artist, who is running a community art installation project on behalf of Frogpool Chapel. Over the next month the children will be involved in workshops at school to create a piece of artwork that forms a major part of this project. Every child in school will be part of the project and their work will be displayed in this community space. Very exciting and more details will follow.

I would like to once again, address some issues which have been a continual cause for concern.

Firstly, parking. Whilst I realise it is difficult to park outside of the school, I would ask that you do not obstruct people's driveways and other entrances such as lanes and the South West Water gates. We regularly receive complaints from residents about the parking and would ask you to consider the impact of blocking an access in an emergency. Also, it would be helpful if parents collecting children at the end of the day could ensure that there is enough room on the pavement for children to walk safely to/with their parents and there should be no parking on the pavements. Also parking on the bridge, remember larger vehicles need to pass through our village, and if cars are not parked tight to the verge, this also has caused some problems in recent weeks. Lastly, it would be appreciated if once you have collected your child you make your way home to relieve any congestion.

Secondly, I have noticed recently that some drivers in our village have been travelling very fast. Please remember that whatever the speed limit may be outside of the school, caution should be taken at **all** times with regard to speed
